A RESOLUTION ADOPTING PUBLIC PARTICIPATION PROCEDURES

TO AMEND THE VILLAGE OF LANNON, WISCONSIN COMPREHENSIVE PLAN

WHEREAS, pursuant to Section 66.1001 of the *Wisconsin Statutes*, all units of government which amend official mapping ordinances on or after January 1, 2010, must adopt a Comprehensive Plan; and

WHEREAS, the Village of Lannon adopted a Comprehensive Plan under the authority of and procedures established by Section 66.1001 of the *Wisconsin Statutes* on June 11, 2018; and

WHEREAS, Section 66.1001(4) (a) of the *Wisconsin Statutes* requires that the Village Board of Trustees adopt written procedures designed to foster public participation during the amendment of a Plan; and

WHEREAS, the Board of Trustees of the Village of Lannon believes that meaningful public involvement in the Comprehensive Plan amendment process is important to assure that the Comprehensive Plan continues to reflect input from the public; and

WHEREAS, public participation procedures have been developed to foster public participation in the Comprehensive Plan amendment process.

NOW THEREFORE, BE IT RESOLVED, that the Village Board of the Village of Lannon hereby adopts the Public Participation Procedures to Amend the Comprehensive Plan attached hereto as Exhibit A to fulfill the requirements of Section 66.1001(4) (a) of the *Wisconsin Statutes*.

EXHIBIT A

**PUBLIC PARTICIPATION PROCEDURES
FOR AMENDING THE COMPREHENSIVE PLAN OF THE VILLAGE OF LANNON**

On June 11, 2018, the Village of Lannon Board of Trustees adopted an amendment to its Village Comprehensive Plan under Section 66.1001 of the Wisconsin Statutes, which is documented in a report titled "Lannon Comprehensive Plan Amendment".

The following describes the process the Village will follow for public participation in the consideration of updates and amendments to the Comprehensive Plan.

The Village of Lannon Plan Commission will meet in open session to review the Comprehensive Plan draft map or amendment. Additionally, the Plan Commission will hold a Public Hearing on March 28, 2019 at 6:00 p.m., this publication provides 30 days of notice for the public to review the AMENDMENT and to provide written comments to the Village Clerk or to attend and comment at the Public Hearing at the noticed Plan Commission meeting. Copies of the AMENDMENT will be available for public viewing at the Lannon Village Hall at 20399 W. Main St. Lannon WI 53046 from 8:00 a.m. to 4:00 p.m. Monday through Thursday or on the Village of Lannon website. Interested parties are also able to make arrangements with the Village Clerk to obtain a copy of the AMENDMENT under the Wisconsin public records statute.

The Plan Commission will review the written comments and suggestions provided by the public, as well as those comments received at the Public Hearing. These comments will become part of the formal record. The Plan Commission will make modifications as they believe necessary to the Comprehensive Plan update.

After thorough review and consideration, the Plan Commission will approve the AMENDMENT to the Comprehensive Plan with a majority vote of the entire Commission and adoption of a Resolution approving the update, thereby recommending that the Village Board enact an Ordinance formally adopting the AMENDMENT update.
