MINUTES OF THE VILLAGE BOARD MEETING FROM 5/13/19

1. Call to order by presiding officer. President Gudex called the meeting to order at 7:00 p.m.
2. Pledge of Allegiance was recited.
3. Roll Call: Barbieri, Gizelbach, Gudex, Manor-Schmidt, Reek and Yates were present. Nellis was absent
4. Statement of Public Notice was confirmed.
5. Discussion and possible action on the reading, correction and approval of the minutes from the joint Plan Commission/Village Board meeting from March 28, 2019. Reek/Gizelbach motioned to approve the meeting minutes from 3/28/19. Motion carried unanimously.

12. Discussion and possible action for Temporary Class "B" license for Lannon Junior baseball for June 15, 2019 to June 16, 2019. Reek/Yates motioned to approve the temporary Class "B" license for the baseball club. Motion carried unanimously.
13. Discussion and possible action on Transient Merchant Application for Aptive Environmental. Barbieri/Gizelbach motioned to approve the application for Aptive Environmental. Motion carried unanimously.
14. Discussion and possible action on Transient Merchant Application for Storm Fireworks. Gizelbach/Reek motioned to approve the application for Storm Fireworks. Motion carried unanimously.
15. Discussion and possible action on Used Auto Dealer license for Lannon Motors at 20365 W. Main St. The application is just in the other partners name who is taking over the business. Reek/Barbieri motioned to approve the auto dealers license. Motion carried unanimously.
16. Discussion and possible action on appointment of Plan Commission member. Randy Bembenek lives in the Village across from Rams. Barbieri/Reek motioned to approve the appointment of Randy Bembenek to the Plan Commisison. Motion carried unanimously.
17. Discussion and possible action to authorize the negotiation of an agreement with the Town of Lisbon to enable Lannon Village Residents to use the Town of Lisbon Compost Site. President Gudex stated he had a discussion with the Town of Lisbon with using their compost area. It would cost our residents \$40/year if they want to use it. Gudex motioned to allow our residents to pay the \$40 to use the dump in the Town of Lisbon before we enter into the agreement. No second. Yates/Gizelbach motioned to authorize the negotiation and review the contract to use the compost site in the Town of Lisbon. Motion carried unanimously.
18. Discussion and possible action on the payment of bills. Yates/Reek motioned to pay the bills. Motion carried unanimously.
19. Engineer's Report. Lemke Stone, Water main project, no updates on the schedule, agreement has not been executed yet. Yates questioned if we are going to let the resident know. Whispering Ridge preliminary plat was received today so we may be looking at a Joint meeting on May 30th. Lannon Interceptor, drive on a motor went out in the Village of Sussex. 15 units sold in Overstone.

Presentation to report on status of exploration of the availability of financing assistance from third party sources such as the United States Department of Agriculture [USDA] and technical and procedural challenges associated with the expansion of the water system within the Village of Lannon. There was a brief introduction by Engineer Ben Wood to explain why we need to go into closed session with the past water issues. If we are looking at building out the water system and the financial costs, feasibility, etc.

Roll Call Vote: Gizelbach – yes, Reek-yes, Gudex- yes, Barbieri-yes, Yates- yes, and Manor-Schmidt – yes. Motion carried unanimously.
