

VILLAGE OF LANNON POLICE DEPARTMENT

MEMO: Monthly Activity – August, 2021

DATE: Thursday, September 9, 2021

The following is a summary of activity for the month of August, 2021:

1st, 10:00 PM: WSD responded to a report of a subject breaking into autos in the parking lot at a rooming house on N. Lannon Rd. The call was baseless and the caller was found to have mental health issues.

1st, 11:50 PM: WSD and Menomonee Falls PD responded to a call of a woman with a knife threatening to kill her son on N. Lannon Rd. It was determined not to be a credible threat.

2nd: The water main installation began on Main St. between Flagstone Pass and Townline Rd. Westbound traffic on Main St. was diverted at Good Hope Rd. Additional signs were later installed. Officers have conducted an education and enforcement effort in the area. About 38 related citations were issued in August.

3rd, 6:37 AM: Chief Bell investigated a car vs. bicyclist accident at Good Hope and Main Sts. The bicyclist was hospitalized with serious injuries. The car driver was cited.

5th, 2:00 PM: Construction crews struck a gas line on Main St. near Whispering Ridge. WE Energies repaired same.

5th, 10:18 PM: WSD handled a trespassing complaint on W. Main St. The father of a resident was refusing to leave but was gone on deputies' arrival.

8th, 2:01 PM: Chief Bell located a stolen auto from Milwaukee in the parking lot of WI Firearms. Investigation revealed that the employee borrowed the vehicle and did not have knowledge that it was stolen. The vehicle was towed and returned to its owner.

10th, 9:30 AM: A Whispering Ridge resident was cited for disorderly conduct after driving the wrong way in the Main St. construction zone and then threatening the workers.

10th, 10:50: A Lannon Estates resident approached a Village Trustee with concerns about a neighbor chronically making noise and violating park rules. Chief Bell spoke to the complainant and she declined police involvement at this time.

11th, 7:00 AM: Chief Bell investigated a natural death that occurred at a residence on W. Good Hope Rd.

13th, 8:29 AM: Chief Bell located a semi on F&W Court that was wanted for striking a pole in Menomonee Falls. The driver did not realize he struck the pole. MFPD investigated.

13th, 12:45 PM: Chief Bell responded to a traffic hazard (gravel spill) on Townline Rd. north of Main St. Traffic was directed until the spill was removed.

13th, 4:00 PM: Officer Wearing assisted WSD with execution of a warrant in a rooming house on N. Lannon Rd. regarding an investigation they are conducting.

13th, 5:30 PM: Officer Wearing investigation a gas drive-off at Lannon BP. The suspect was located and returned to pay.

14th, 2:48 PM: WSD investigated a truck fire at Daily Express, caused by a mechanical problem.

14th, 7:00 PM: Officer Lang investigated a disorderly conduct complaint in Lannon Estates. A resident was cited after causing a disturbance by shouting profanities.

16th, 4:00 AM: A resident of a rooming house on N. Lannon Rd. claimed she was being chased by a man with a gun inside the building. WSD determined the complaint was baseless. The caller has mental health issues.

16th. 9:50 AM: Chief Bell mediated a dispute between a resident of Main St. and a developer who is building next door, regarding moving dirt.

16th, 5:13 PM: Lt. Bethia arrested a motorist for warrants and conveyed the subject to the county jail.

17th, 5:00 AM: Chief Bell investigated a complaint of a speeding vehicle on N. Lannon Rd. at the same time every day. On this occasion the vehicle was not speeding.

17th, 12:50 PM: Chief Bell investigated a property damage only accident that occurred on Lannon and Good Hope Rds.

17th, 2:15 PM: Chief Bell was dispatched to a report of motorists arguing at Main St. and Good Hope Rd. The parties were not located.

17th, 3:26 PM: Chief Bell was flagged down for an accident in the lot at Lannon BP. Parties did not require police assistance.

18th, 3:35 AM: WSD responded to a trespassing complaint on W. Good Hope Rd. The caller observed an unknown person in her yard. WSD was unable to locate anyone.

18th, 8:41: Chief Bell was dispatched to trouble with an employee at a business on Edgewood Dr. The employee refused to leave after being fired. She later fought and was eventually cited for disorderly conduct.

18th, 9:40 AM: Chief Bell investigated a gas drive-off at Lannon BP. Video surveillance did not capture the license plate of the auto.

18th, 3:43 PM: Officer Biedenbender assisted WSD with a drowning that occurred in Menomonee Park. Biedenbender was first on scene and performed CPR on the patient, who sadly did not survive.

18th: Lannon PD hosted their National Night Out in Lions Park. WSD, Menomonee Falls FD, Halquist Stone, Gessler's Towing, Flight for Life and Dairyland Bus staffed displays for approximately 150 attendees. Jack Moss Trucking volunteers staffed the raffle station. It was a success by all accounts because of generous donations provided by Lannon businesses.

21st, 11:56 AM: Officer Polka returned a stray dog to its owner on W. Main St.

21st: Lannon PD officers were present for the 90th Anniversary celebration in Joecks Park. There were no incidents.

21st, 1:49 AM: WSD responded to a trespassing complaint on W. Good Hope Rd. Caller reported seeing a figure in the yard. WSD was unable to locate anyone. This was the same caller as the incident on the 18th.

21st, 7:23 AM: WSD dispatched a deer whose antlers were entangled in a soccer net at Calvary Baptist School.

21st, 9:05 AM: WSD responded to Rock Pointe for a 2-year old who locked the parents out of the apartment. Entry was gained.

21st, 6:46 PM: Officer LaGosh investigated a complaint of a court order violation on W. Main St. It was determined that no violation had occurred.

24th: Chief Bell investigated two gas drive-offs at Lannon BP. Both individuals later returned to pay.

24th, 7:15 PM: A resident of a rooming house on N. Lannon Rd. was caught entering an auto in the Mibb's & Viv's parking lot looking for change. The vehicle owner declined to prosecute. The subject was cited and later evicted.

24th, 9:40 PM: WSD responded to a man pounding on the windows of Twelve29 asking for a ride. He was eventually picked up.

28th, 1:26 PM: WSD investigated a theft of cash from a residence on Good Hope Rd. The investigation is ongoing.

29th, 2:47 PM: Lt. Bethia checked the welfare of a subject on Good Hope Rd. who was reportedly intoxicated. The subject was found to be sober.

29th, 11:30 PM: WSD investigated a theft of dog on Good Hope Rd. It was found to have been taken by a relative.

30th, 6:10 PM: Officer Wearing was sent to a threat complaint on W. Main St. The female who made the threats was later seen on Main St.

screaming profanities at passing autos. Officer Wearing attempted to interview her at which time she fought with the officer. The female was ultimately arrested and conveyed to the county jail. She was under the influence of drugs and had recently been evicted from a rooming house on N. Lannon Rd.

31st, 3:09 PM: Officer Lang investigated a theft that occurred in Rock Pointe apartments. The investigation is ongoing.
