

## VILLAGE OF LANNON POLICE DEPARTMENT

MEMO: Monthly Activity – September, 2021

DATE: Monday, October 4, 2021

The following is a summary of activity for the month of September, 2021:

2<sup>nd</sup>, 12:25 PM: Chief Bell responded to suspicious subjects exchanging items in a business parking lot on W. Main St. They did not possess any contraband and were advised to leave.

2<sup>nd</sup>, 4:30 PM: Officer Wearing investigated a property damage only crash in the Lannon BP parking lot.

3<sup>rd</sup>, 9:11 AM: Lt. Bethia addressed a citizen complaint of an earth mover (heavy construction equipment) driving on village streets. The owner was advised not to do this in the future.

3<sup>rd</sup>, 10:00 PM: WSD handled a call of wires down at Lannon and Good Hope Rds.

5<sup>th</sup>, 12:02 PM: WSD assisted EMS with a medical call in the 7300 block of N. Lannon Rd.

5<sup>th</sup>, 4:58 PM: WSD took a burglary report on W. Good Hope Rd. A vacant house was entered, items were removed and the basement was vandalized. Charges were later filed against the former tenants.

5<sup>th</sup>, 7:57 PM: WSD handled a vehicle lockout in Lannon Estates.

7<sup>th</sup>, 12:30 AM: WSD responded to a well-being check on W. Good Hope Rd. for a reportedly intoxicated subject. He was found to be OK.

7<sup>th</sup>, 11:50 AM: A citizen reported a fire after a nearby lightning strike at Schlafer Auto. The fire was actually a controlled burn and there was no lightning damage found.

8<sup>th</sup>, 10:00 AM: Senator Scott Fitzgerald held a community meeting at the Village Hall.

8<sup>th</sup>, 12:30 PM: Chief Bell took a complaint of threatening text messages at an address on W. Main St. The suspect was referred to the DA's office.

8<sup>th</sup>, 1:35 PM: Chief Bell responded to the Bugline Trail near Townline Rd. for a bicyclist with a medical issue.

9<sup>th</sup>, 10:00 PM: An unknown actor stole a dog crate from a porch on W. Good Hope Rd. Chief Bell took the report.

10<sup>th</sup>, 12:29 PM: Lt. Bethia assisted at an EMS call on Forest View in which a resident fell from a tree.

10<sup>th</sup>, 7:45 PM: Chief Bell removed a fallen tree that was blocking traffic in the 21300 block of W. Good Hope Rd.

11<sup>th</sup>, 12:57 PM: WSD responded to a burglar alarm at a business on N. Townline Rd. It was a false alarm.

11<sup>th</sup>, 8:30 PM: Officer LaGosh took a report of three vehicles that were entered at a different business on Townline Rd. It is likely this actor set off the alarm mentioned above. Nothing was taken from the vehicles. Surveillance cameras showed the actor was a juvenile.

13<sup>th</sup>, 6:20 PM: Officer Biedenbender assisted WSD with a domestic violence investigation. The victim walked into our village from Sussex where the incident occurred.

13<sup>th</sup>, 11:05 PM: A citizen observed 2 individuals in the act of stealing a catalytic converter from a car at Circle S Storage. WSD and MFPD responded at which time the individuals fled on foot in separate directions. A WSD K-9 was used to track the suspects, but they were not located. Nearby jurisdictions have experienced similar thefts.

15<sup>th</sup>, 3:05 PM: Chief Bell checked for a reckless auto on Main St. reported by WSD. It was not located.

16<sup>th</sup>, 7:55 AM: Chief Bell received a report of property stolen from a garage on Main St. by a known suspect.

16<sup>th</sup>, 9:20 AM: A different business on Townline Rd. reported vehicles having been entered over the past weekend. Nothing was taken. Extra patrols and surveillance cameras were installed by Chief Bell.

16<sup>th</sup>, 12:20 PM: Chief Bell assisted EMS with a subject who fell off her bicycle on the Bugline near Townline Rd.

17<sup>th</sup>, 3:00 AM: WSD assisted EMS with a resident who fell on Overlook Ct.

17<sup>th</sup>, 12:30 PM: A piece of construction equipment snagged overhead lines in the 19400 block of W. Main St. A pole broke and wires subsequently hung low over Main St. blocking traffic. Chief Bell and Officer Lang directed traffic around the incident.

17<sup>th</sup>, 7:40 PM: Officer Lang assisted WSD with traffic control at a barn fire in Sussex.

18<sup>th</sup>, 11:00 AM: Chief Bell was alerted to an intruder in the yard at a business on Townline Rd. WSD responded and caught the juvenile responsible for the previous trespassing incidents.

18<sup>th</sup>, 8:23 PM: A resident reported hearing a baby crying uncontrollably in the 7300 block of N. Lannon Rd. Officer LaGosh responded twice to the area without locating the source. The caller was intoxicated.

18<sup>th</sup>, 10:29 PM: Officer LaGosh arrested an intoxicated driver on W. Good Hope Rd.

20<sup>th</sup>, 7:02 AM: Officer LaGosh responded to a burglar and fire alarm in the 19300 block of W. Main St. A faulty alarm component was the cause.

20<sup>th</sup>, 11:58 AM: Officer LaGosh assisted WSD with locating a missing juvenile in Menomonee Park.

21<sup>st</sup>, 2:45 PM: Chief Bell investigated a gas drive-off from Lannon BP. The subject was located and later returned to pay.

21<sup>st</sup>, 9:30 PM: WSD responded to a burglar alarm at WI Firearms, which was a false alarm.

23<sup>rd</sup>, 12:16 PM: Lt. Bethia responded to a burglar alarm on Overstone Drive. False alarm.

25<sup>th</sup>, 4:43 PM: A Lisbon resident reported a semi blocking the roadway on Townline Rd. near Good Hope Rd. The truck moved prior to police arrival.

27<sup>th</sup>, 2:05 PM: A construction worker in the area reported a theft from a vehicle to Chief Bell. The date of the theft is unknown. The incident is currently under investigation.

27<sup>th</sup>, 2:55 PM: A resident reported an attempted identity theft to Chief Bell. An actor obtained complainant's information and applied for credit which was denied.

27<sup>th</sup>, 3:40 PM: A resident reported losing money in a fraudulent investment scheme conducted on the internet. Investigation revealed the suspects are overseas.

28<sup>th</sup>, 1:10 PM: A citizen called in a possibly intoxicated driver on Diamond Dr. The vehicle left prior to officer's arrival.

28<sup>th</sup>, 6:00 PM: Lt. Bethia investigated suspicious subjects on Park View Dr. asking residents for water. The juveniles involved were located and cautioned against doing same.

29<sup>th</sup>, 7:37 PM: Officer Lang assisted WSD in locating a DV suspect in Sussex.

30<sup>th</sup>, 5:22 PM: Officer Lang handled a personal injury crash at Lannon and Good Hope Rds.

Officers responded to approximately sixteen 911 open line or hang up calls in September.
