MEMO: Monthly Activity – December, 2021

DATE: Tuesday, January 4, 2021

The following is a summary of activity for the month of December, 2021:

1st, 1:30 PM: Chief Bell responded to Lannon BP for a man acting strangely and not leaving after pumping gas. A ride was obtained from a relative.

2nd, 9:15 AM: A gas drive-off occurred at Lannon BP. No license plate was obtained by the cameras.

2nd, 10:20 AM: Chief Bell took a report of trespassing on the Daily Express property. This has been occurring over the past several weeks. A suspect was identified and will be cited.

2nd, 3:00 PM: Chief Bell issued a citation to a resident on W. Good Hope Rd. for junked vehicles.

3rd, 2:27 AM: WSD responded to a suspicious subject in the 20400 block of W. Good Hope Rd. They were unable to locate him.

3rd, 12:20 PM: Chief Bell issued a compliance letter for junked autos at a residence near Good Hope Rd. and Main St.

3rd, 7:00 PM: The annual Christmas Tree Lighting took place at Village Hall. Santa and Elvis were in attendance. No incidents were reported.

6th, 3:00 PM: A road rage incident occurred in Menomonee Falls in which one driver allegedly pointed a gun at another. Chief Bell located the subject inside WI Firearms and found he was armed. MFPD responded and ordered the subject to appear at a future date.

7th, 1:40 PM: Chief Bell issued two compliance letters for junked autos to residents on Main St.

9th, 11:10 AM: Chief Bell responded to a material spill on the road at Main and Townline. It was determined to be water.

9th, 4:20 PM: Officer Biedenbender responded to Lannon BP for a suspicious subject. It was found he was attending to issues with his vehicle.

10th, 6:45 AM: A worker's vehicle caught fire at Rock Pointe Apartments. The fire started in the engine compartment. The vehicle was totaled.

10th, 4:55 PM: Officer Wearing assisted MFPD with a traffic stop at Lannon and Good Hope Rds. at their request. The violations occurred in their jurisdiction.

12th, 8:04 AM: WSD investigated a crash in the 19500 block of W. Main St. in which a vehicle left the roadway and struck a house. The driver sustained minor injuries.

12th, 11:49 AM: WSD responded to a violation of court order in the 21200 block of W. Main St. The violator was gone on arrival.

13th, 10:50 PM: WSD responded to assist EMS with a medical call in Lannon Estates.

15th, 4:58 AM: WSD responded to a false intrusion alarm at ChemRite Industries.

15th, 9:39 PM: A second false alarm occurred at ChemRite. The company is working with their security vendor to address the issue.

15th, 10:00 PM: WSD responded to an EMS call on Forest View Dr.

16th, 3:00 PM: The Department received information concerning a "school shooting challenge" on TikTok scheduled for December 17th. Additional walk-throughs, extra patrols and monitoring of pickups and drop-offs were conducted at schools through December 22nd in response to the threat.

16th, 7:00 PM: Lannon PD and WSD investigated a social media post that was determined to be threatening considering the current TikTok challenge. A Lannon juvenile was taken into custody and Hamilton School District classes were canceled on the 17th as a result.

16th, 9:36 PM: WSD investigated a domestic violence incident in Lannon Estates. One subject was arrested for battery and drug possession.

16th, 10:31 PM: WSD responded to a suspicious truck leaving Lannon Quarry at a late hour. They were unable to locate the vehicle. It did not pass the locked gate.

17th, 10:06 AM: Chief Bell responded to Main St. near Sunnyside Cemetery for a pedestrian stumbling in traffic. He was given a ride to a nearby gas station where he was picked up by a friend.

17th, 10:40 AM: Chief Bell responded to a stray dog on Townline and Bonnie Lane. It was returned to the owner by a resident.

17th, 12:30 PM: A resident reported a fraudulent charge on his credit card. A report was filed at the request of the card issuer.

18th, 12:30 PM: Officer Wearing responded to an alarm at a business on Edgewood Dr. A door was found to be open but no entry had been gained.

21st, 2:39 PM: Lt. Bethia responded to a false fire alarm at Lannon Elementary School.

22nd, 10:00 AM: Chief Bell responded to a report of a vehicle blocking traffic in the 7000 block of N. Lannon Rd. It was gone on arrival.

22nd, 7:37 PM: Officer Lang stopped a vehicle for a traffic violation near Lannon and Main. The vehicle then fled. The auto listed to a rental company which provided the renter's name. The investigation is ongoing.

24th, 6:12 PM: WSD responded to an address on Overstone Dr. for an EMS call.

26th, 11:34 AM: WSD responded to a possible theft from a construction site in the Overstone development. Chief Bell later determined that no theft had occurred, the auto involved belonged to a contractor.

27th, 5:47 PM: Lt. Bethia located a missing dog in Lannon Estates and returned it to the owner.

27th, 10:35 PM: WSD responded to a suspicious auto near Lannon and Good Hope Rds. It was found to be driven by a subject who lived in the area who was recently evicted. WSD located the subject the following night and gave him a ride to a local hotel.

28th, 1:15 PM: Chief Bell investigated an anonymous report of painters smoking marijuana in the Overstone development. No evidence was found and the workers were warned.

28th, 3:10 PM: Chief Bell responded to a reckless auto on Good Hope Rd. westbound from Menomonee Falls. The vehicle was located and the driver was cited.

30th, 9:23 AM: Chief Bell responded to a call of a female who appeared to have been beaten walking on Main St. It was found she was the victim of a domestic violence incident that occurred in Sussex. WSD investigated the incident and the female was conveyed to a safe location.
