1st, 12:43 PM: Officer Lang conducted a well-being check at an address on W. Good Hope Rd. All was in order.

1st, 4:20 PM: Lt. Bethia responded to a report of a possible drunk driver at Lannon Rd. and Main St. The driver was found to be distracted but not drunk.

- 16th, 8:30 AM: A business on Townline Rd. wanted it noted that the business next door who is re-grading their property inadvertently dug up part of the complainant's property. The parties are handling the issue themselves at this point.

- 16th, 11:20 AM: Chief Bell responded to Lannon Elementary School to assist in counseling a child who left school grounds.
