July 1st, 8:04 AM; 911 open line, Rock Pointe Way. Accidental dial.

1st, 3:10 PM: Chief Bell assisted WSD in Sussex with an uncontrollable juvenile.

1st, 2:04 PM: Chief Bell investigated a rear-end property damage collision on N. Lannon Rd. near the Bugline Trail.

1st, 10:57 PM: Drugs complaint, W. Good Hope Rd. Intoxicated caller gave vague information about a subject selling drugs, unable to locate.

2nd, 11:19 AM: Dispute, N. Lake St. A resident reported being unsatisfied with the quality of the landscaping done after water lines were installed.

2nd, 2:44 PM: Well-being check, Good Hope & Lannon Rds. An individual who appeared intoxicated was stumbling down the road. Unable to locate.

2nd, 8:45 AM: Chief Bell warned several residents near Townline and Good Hope Rds. regarding fireworks.

4th, 2:30 PM: Theft, Lannon Estates. A Brookfield resident reported her purse and phone were stolen at Alpine Valley yesterday and her phone was now pinging to an address in Lannon Estates. Chief Bell made contact with a resident who works at Alpine Valley and found the property in her backpack, stating she didn't know how it got in there. Complainant was satisfied getting her property back.

5th, 7:45 AM: Parking issue, N. Lannon Rd. A straight truck has been parked on N. Lannon Rd. near the Bugline Trail for several days. The truck is normally kept at K-Kom but they are having their driveway resealed. The truck should be moved by 7/6.

6th, 6:45 PM: Ambulance call, Bugline Trail & Good Hope Rd.

7th, 3:07 PM: Officer Chin was at the courthouse conducting follow up on a burglary investigation when a call came over of a mentally disturbed subject trying to enter autos in the courthouse parking lot. Officer Chin responded, the subject was ultimately arrested and turned over to deputies.

7th, 9:18 PM: Fireworks, Good Hope Rd. east of Townline Rd. Deputies were unable to locate. A message was sent out on social media asking residents to refrain from using fireworks.

8th, 10:57 PM: 911 open line, 20500 block of W. Main St. Unintentional dial.

9th, 12:16 PM: Well-being check, Rock Pointe Way. The resident was fine.

9th, 7:01 PM: 911 no cause, W. Birchwood Dr.

10th, 10:30 AM: Assist other agency (State Patrol), W. Overstone Dr. Troopers requested we contact the registered owner of a vehicle they had stopped and ask if it was stolen, it was not.

11th, 1:30 PM: Well-being check, N. Lannon Rd. A resident made suicidal statements and was ultimately conveyed to a hospital for mental health treatment.

11th, 5:30 PM: Domestic dispute, W. Good Hope Rd. The male half was later cited for disorderly conduct.

11th, 7:00 PM: Officer Picard was approved to be hired at the board meeting.

12th, 2:00 PM: A citizen reported numerous zoning violations throughout the village including vehicles parked on lawns, illegal signage, and loud trucks. The concerns are being addressed.

12th, 9:00 PM: Alarm, ChemRite. False alarm

12th, 9:56 PM: Mental commitment, Lannon Estates. Safety plan was implemented for a suicidal resident.

13th, 8:10 AM: Chief Bell advised a business on W. Good Hope Rd. to remove excessive signage in the right of way.

13th, 9:15 PM: Chief Bell wrote a letter to a resident on W. Main St. regarding bushes overgrowing the sidewalk and junked autos.

13th, 10:45 AM: Chief Bell accompanied a humane officer to confiscate a vicious dog in Lannon Estates.

13th, 8:44 PM: Ambulance call, Lannon Estates.

15th, 11:40 AM: Well-being check, Whispering Ridge. A resident sent a cryptic text implying she might be suicidal. She was found to be fine.

16th, 12:44 AM: Fireworks complaint, near Good Hope and Willow Lane. Deputies were unable to locate.

16th: The Police Department hosted a bike rodeo at Lannon Elementary School. 19 children attended. Sponsors included Target, Walmart, McDonald's in Sussex, and Kraverz in Menomonee Falls. Two children's bicycles and helmets were given away.

17th, 12:07 PM: Ambulance call, W. Bonnie Ln.

18th, 10:00 AM: A ChemRite employee reported losing a purse and ID card. A report was filed.

18th, 10:30 AM: Ambulance call, W. Main St.

20th, 5:41 PM: Ambulance call, 20400 block W. Good Hope Rd.

22nd, 5:17 AM: Ambulance call, Whispering Ridge.

22nd, 6:30 PM: Suicide threat, Overstone Drive. An intoxicated resident made numerous cuts to her wrists and held a knife to her throat threatening suicide. Subject was disarmed and taken into custody for a mental commitment.

23rd, 12:00 PM: Suspicious vehicle, Whispering Ridge. Driver was waiting for a resident. No cause.

26th, 6:57 AM: Ambulance Call, Overstone Dr.

27th: Chief Bell wrote a letter to a resident of W. Main St. regarding noxious grass and weeds.

28th, 3:43 AM: Suspicious, Overstone Dr. A resident's garage door was found open by deputies. All was in order.

28th, 9:50 AM: Lannon BP reported a worthless check issued to them weeks ago. The check writer was located and later returned to settle the debt.

28th, 10:20 AM: A resident of N. Lannon Rd. filed a complaint of worthless checks. The investigation is pending.

29th, 6:30 PM: A caller reported numerous juveniles and vehicles in the roadway on N. Lannon Rd. They were gone on arrival.

31st: The Cars on Main car show was staffed by 11 officers throughout the day. There were two EMS calls and no calls for police service. Five citations were written at the end of the show to drivers doing burnouts or driving around barricades.
