October 1<sup>st</sup>, 1:50 PM: Suicidal subject, Lannon Estates. Safety plan put into place by crisis workers.

2<sup>nd</sup>, 8:19 PM: Suicidal subject, W. Forest View Drive. Crisis did not take any action.

3<sup>rd</sup>, 9:15 AM: Landlord-tenant trouble, N. Townline Rd. The tenant refused to remove junk property and was unreachable. Eviction notice to follow.

3<sup>rd</sup>, 2:32 AM: Well-being check, Lannon Estates. Officers conducted a well-being check on the same subject who threatened suicide on the 1<sup>st</sup>. Subject refused to let officers enter.

3<sup>rd</sup>, 10:20 AM: Maintain the peace, W. Forest View Drive. Officer Chin mediated a dispute, all parties were satisfied.

3<sup>rd</sup>, 12:00 PM: Assist other agency (ATF). Officers Chin and Stormoen assisted in execution of a search warrant in the village by the ATF. Our village hall was utilized for citizen interviews following the warrant.

3<sup>rd</sup>, 8:03 PM: Assist other agency (Menomonee Falls PD). Officer Stormoen assisted MFPD with a shots fired complaint in their village.

October 5, 10:10 AM: Domestic, Rock Pointe Apartments. The male half was arrested for battery.

5<sup>th</sup>, 5:30 PM: Missing (stolen) firearm, WI Firearms. Gun went missing following a gun show in Milwaukee. Report taken by ATF.

- 6<sup>th</sup>, 2:08 AM: Domestic, Rock Pointe Apartments. One subject arrested for battery. Not related to the arrest on the 5<sup>th</sup>.
- 6<sup>th</sup>, 3:00 AM: Domestic, Lannon Estates. Alleged victim refused to cooperate with deputies, no arrests were made.
- 8<sup>th</sup>, 9:52 PM: Maintain peace, Lannon Estates. Officers stood by for a property pickup.
- 9<sup>th</sup>, 6:00 AM: Domestic, Lannon Estates. Caller stated she wanted to kill her husband. Parties reconciled, no action was taken by crisis.
- 9<sup>th</sup>, 3:45 PM: Ordinance violation (unattended fire), United Stone. Owner was advised.
- 9<sup>th</sup>, 4:15 PM: Reckless vehicles (ATVs), Rock Pointe Apartments. Caller reported teens on ATVs in the construction area near Custer and Main. Subjects were located and warned, parents were advised.
- 11<sup>th</sup>, 7:55 AM: Ambulance call, Lannon Estates.
- 11<sup>th</sup>, 11:50 AM: Dispute, N. Townline Rd. Chief Bell witnessed an eviction notice being served to tenant with illegal junkyard behind Artistic Stone.
- October 13, 7:55 AM: Gas skip, Lannon BP. The subject's vehicle was located and the customer returned to pay for the gas.
- 13<sup>th</sup>, 11:20 AM: Ambulance call, 7200 block N. Lannon Rd.

- 17<sup>th</sup>, 3:49 AM: Alarm, Dugout. False alarm.
- 17<sup>th</sup>, 11:10 AM: Accident, 21300 block W. Good Hope Rd. A trailer became disconnected from an auto and rolled onto the lawn of a business.
- 17<sup>th</sup>, 7:30 PM: Assist other department (Waukesha PD). Officer Stormoen responded to Waukesha for a report of an active shooter, which was a hoax.

17<sup>th</sup>, 8:39 PM: Accident, Lannon & Good Hope. An eastbound auto failed to stop for the stop sign.

20<sup>th</sup>, 10:20 AM: Numerous area schools were the subject of false active shooter calls. Chief Bell walked through Lannon Elementary, St. John's Lutheran and Calvary Baptist schools and advised administrators of the hoaxes. No Lannon schools were involved.

20<sup>th</sup>, 11:30 PM: 911 hang up, 20500 block W. Main St. Unable to locate.

21<sup>st</sup>, 7:29 PM: Assist other agency (Menomonee Falls PD), Menomonee & Townline. Lt. Lang directed traffic at a 2-car accident in which a driver was arrested for drunk driving.

22<sup>nd</sup>, 10:00 PM: Chief Bell and Lt. Lang attended the Trunk or Treat event at Waukesha County Expo Center along with numerous other police departments. Candy was provided to appx. 300 children, some of whom were from Lannon.

22<sup>nd</sup>, 5:00 PM: Lt. Lang monitored the trick or treat activity in Lannon Estates.

23<sup>rd</sup>, 9:30 PM: 911 hang up, Rock Pointe Way. All was in order.

24<sup>th</sup>, 10:05 AM: County Highway Dept. repaired the traffic signals at Lannon and Main which had been stuck flashing red all weekend.

24<sup>th</sup>, 11:50 PM: Ambulance call, 20000 block W. Good Hope Rd.

25<sup>th</sup>, 2:45 PM: Theft, Green Acres. A tenant reported a catalytic converter stolen from his vehicle parked outdoors sometime since April.

25<sup>th</sup>, 3:38 PM: Rollover crash, 6900 block N. Lannon Rd. A driver had a seizure behind the wheel and struck another auto, a sign and a tree. Both drivers sustained minor injuries.

26<sup>th</sup>, 7:40 AM: Property damage, 19500 block W. Main St. Don Sommers reported an auto made a U-turn in a driveway damaging the grass.

- 26<sup>th</sup>, 6:25 PM: Reckless auto, Lannon & Bugline. Lt. Lang stopped a driver who stated his GPS took him onto the Bugline Trail.
- 26<sup>th</sup>, 7:55 PM: Reckless auto, Lannon & Main. A vehicle was reportedly driving erratically and occupants yelling out the window. Vehicle was not located.
- 27<sup>th</sup>, 1:00 AM: Domestic, Lannon Estates. The male party was arrested for battery.
- 27<sup>th</sup>: The new squad car came back from the outfitter and was placed into service.
- 27<sup>th</sup>, 4:45 PM: 911 no cause, Rock Pointe Apartments. A child was playing with the phone.
- 27<sup>th</sup>, 8:45 PM: Domestic, Lannon Estates. Both parties refused to answer the door for police. Parties were determined to be unhurt.
- 27<sup>th</sup>, 9:30 AM: Neighbor dispute, Lannon Estates. The female half of the previous domestic call was shouting racial slurs at a neighbor. Citation was issued. There have been 23 calls for service at this address in 2022. Nuisance property proceedings will follow. Lannon Estates management is also working to evict these individuals.
- 27<sup>th</sup>, 11:40 AM: 911 no cause, 19800 block W. Main St.
- 27<sup>th</sup>, 7:30 PM: Suspicious auto, 21600 block W. Good Hope Rd. An unoccupied auto was found on the parking lot of the business. Vehicle was eventually removed.
- 28<sup>th</sup>, 12:45 PM: Reckless autos, 20300 block W. Main St. Property owner reports autos driving fast through the parking lot to avoid the intersection of Lannon and Main St. Extra traffic enforcement was implemented.
- 28<sup>th</sup>, 2:00 PM: Suspicious object, Post Office. A red cooler was left on the sidewalk overnight, it was determined to be harmless and was disposed of.
- 29<sup>th</sup>, 10:00 AM: The department hosted a drug take back event. Five pounds of unwanted drugs were recovered.

29<sup>th</sup>: Officers hosted a CCW class at the Village Hall.

30<sup>th</sup>: Officers supervised the Halloween parade and trick-or-treating in the village.

31<sup>st</sup>, 4:20 PM: Traffic hazard, Main & Custer. Someone moved the construction barricades trying to get through the section of closed road.

31<sup>st</sup>, 6:20 PM: Child custody dispute, Lannon Estates. Officer Stormoen mediated the dispute.
