MEMO: Monthly Activity – May, 2023

Date: June 1, 2023

May 2nd, 9:10 AM: reckless auto, Main & Townline. Vehicle later located in Hamilton High School parking lot, driver warned by school resource officer.

2nd, 10:10 AM: Traffic hazard, 7100 block N. Townline Rd. Rocks and mud in roadway from construction project. Owner warned and will sweep the street.

2nd, 2:20 PM: Industrial accident, Lannon Tank. A worker partially crushed his hand in a steel roller. Report filed.
