VILLAGE OF LANNON MINUTES OF THE VILLAGE BOARD MEETING FROM 6/9/2025

- 1. Call to order. President Yates called the meeting to order at 7:00 p.m.
- 2. <u>Pledge of Allegiance</u> was recited.
- 3. <u>Roll Call:</u> Village Board: Battist, Grennier, Lake, Moore, Sommers, Willard and Yates were present. Moore was late.
- 4. <u>Statement of Public Notice</u> was confirmed.
- 5. <u>Discussion and possible action on the reading, correction, and approval of the minutes from the 5/12/25 Village Board Meeting</u>. Lake/Grennier motioned to approve the meeting minutes from 5/12/2025. Motion carried unanimously.
- 6. <u>Committee Reports:</u>
 - a. Finance/Personnel item 23
 - b. Legislative none.
 - c. <u>Parks and Recreation/Beautification</u> Acknowledge the gardeners for planting flowers in the front: Gloria Tofke, Anna Calatola-Robe for the planters and Kelly Wood.
 - d. <u>Public Safety</u> none
 - e. <u>Public Works/Recycling/Sewer</u> Looking into doing shouldering work on Forest View Dr., concerns about tree trimming
 - f. Quarry One Complaint from a blast a couple of weeks ago. He has a blast report, they were within the limits.
- 7. Department Reports:
 - a. <u>Clerk's Office</u> Working on Licenses after the approvals tonight, a USDA compliance call this month and utility billing at the end of the month.
 - b. <u>Police Department</u> informed the public regarding Lt. Lang's resignation.
- 8. <u>Response to previous Citizen Comments</u>. TID questions that will be cleared up tonight during Mr. Cameron's presentation. He will follow up with the AFW foundry site.
- 9. Citizens Comments:
 - (This is meant for Public Comments on any subject, without any discussion by Board of Trustee members or action, except for possible referral to a governmental body or Village agent). Shirley Willard none
 - Jan Manor-Schmidt Good Hope Rd. Jan summarized the Car Show, and the maintenance of the space used for that and also that it is the main area in the Village. They maintain the Village lot as well, they pick up garbage in street as well. The Bartelt's gave the car show over to her family to run. The car show has donated \$25,000 to the Village over the years and donations in Lannon's name to non-profit organizations. We are not paid anything for running the Car Show. We have many volunteers who make this possible. When the discussion comes up again, the board should take this into consideration. Dennis Sherkus Overlook Ct. Status of the land that is for sale. It is in the budget for 2025. Jan Speed in Lannon has been a problem for a really long time. It is horrible down Lannon Rd. It is a racetrack. They are flying through these neighborhoods. There has to be something else that can be done. Speed bumps on Forest View to slow traffic down.
- 10. Update on TID districts by Ehlers and citizen questions. Jon Cameron was present to summarize TID districts. Borrowing capacity is intact and the Developer moves forward with what they said they were going to do so they get their money. Yates questioned what happens if a tax district closes with money? The money gets distributed to the taxing jurisdictions. If it closes with a negative fund balance, the liability stays with the Village. Bumps at TID closure, does it affect people's taxes? One time increase to total levy which is optional – take it or lose it. Levy goes up so does your equalized value so your mill rate should go down. Grennier - TIF or TID? Can they close if they are not ready. Reach the end of its life, fund balance exceeds liability outstanding or voluntarily closing but has not recovered liabilities so the General Property tax would cover that shortfall. Lake regarding Improvement Plans, what if we never created a TID, what would our options be to cover the expenses in the project plan. General Obligation debt and Revenue Bond debt were discussed. You would have to borrow. Your borrowing capacity has grown. Rate increases on the utility. The vehicle to do the things that increase our tax base and get some projects done we wouldn't be able to afford. Battist questioned the proposed senior living facility, what if it is tax exempt? The municipality wouldn't allow that; the developer agreement would address that and require a payment from the facility. MRO payments, hypothetical if they were to close early. TID 1 could close in 2033. Rock Point MRO project out to 2038. If we closed in 2033, do we owe Rock Point that money? You would keep that money in escrow and keep making those payments. How does Ehlers

get paid? Scope of services for a fixed fee to create the TIDs. Prep of project plan, filing documents, meetings, etc. Annual requirements and meetings. That gets paid out of the TID. Budget concerns/constraints, we contribute admin costs to the general fund, what is the mechanism to contribute to costs. We are not eligible to allocate those costs to the TIDS, only capital expenses. Jim Willard – benefits of the districts but haven't talked about the short falls. Diverts revenue from basic services. Any increase in those districts gives us a shortfall to pay for services. Negatives – referendums are the biggest tools right now. Many municipalities went out for referendums which were not successful. They sit on the school side typically, but the municipalities can't bear the expenses. Wheel tax is not popular and is very limited. It gets collected by DOT but can be used in public works. Only applies to regular weight vehicles. Impact fees, garbage charged separately. Stormwater utility. None of these are the magic arrow. We need to educate the public or cut services. Shrinking of TIDS, you have to weigh the options, things you will get bang for your buck. It can't be tied to any MRO but it will not bring in the tax flow. Negative's of TIDS – need for services increases but any development would increase your services. Lack of transparency and oversite. That small board, how much oversite is there. The big meetings were when the TIDS were created, the annual meeting is just a summary of the districts. Water project – petition PSC to reduce the rate of return. Has it ever been done? Alternate revenue services help them be successful with the PSC. TID 1 balance at the beginning of the year? (552,000 in 2024) in 2025 it is over 1 million. 146,842 – 118,589 for 2025. Negative balances because of upfront costs in the TIDS. In 2025 the village owes 188,000 – it gets paid out of the revenues from the TIDS. We earn interest when it goes into the positive. A resident questioned the condition of some of the buildings in the Village. It doesn't have a good look as you drive through. The challenge for the board, you keep getting squeezed. For the greater good they do help us. He would have changed his vote for the referendum after hearing the presentation. How long has land been sitting there with nothing on it. Incremental value if there was a senior center. How does the contract negotiations work. Shirley Willard asked if the lots are in the TIDS? If the Village is lacking money what was the reason for buying the lot. Ben Wood – benefit is utility connection fees. Rock Point paid almost 1 million dollars in connection fees. The RCA fees are about \$8000 for water and \$6000 for sewer. When those TIDS were open the connection fees were a lot higher, which paid the water debt. General Road conditions – 1997 when sewer went in. Road maintenance was deferred because water was going to go in. That water project wasn't planned when TIDS were created. The general funds were not available, so the TIDS were also created to have a bulk at the end to do these projects. Because of the water project we were able to do the roads instead of paying for them. Use the tools available and apply them where they make sense. There is no magic arrow to cover everything however we have used some useful tools.

- 11. Discussion and possible action regarding the ongoing use of Municipal Code Enforcement. Trying to address the concerns of the Village. They came to us at a reasonable rate instead of paying staff. We wanted to raise the aesthetics of the Village based on the new developments, etc. We wanted to eliminate that expense because the money wasn't there however because attorneys, engineers and inspectors cost more than the \$50.00 hour they charged. Have the Board make some sort of decision as a contracted service. We still have issues out there. 40 violations in the Village at any given time. It was a trial thing, but it was well done. They sent the notice and followed up very well and have the time vs the police chief and building inspector. There are offenders that are repeat offenders that will take some legal issues. We directed them to concentrate on some big things in the Village and gained compliance in many areas. We are paying them in lieu of paying the Building Inspector, Police Dept. and Attorneys. The appearance of properties in the Community is a big thing to many people in the Village. Reasonable rate for enforcement. They determined to wait until budget time and see if they can fit it in.
- Discussion and consideration of action to authorize the Village Attorney to commence a Circuit Court enforcement action against the property located at 20712 Main Street owned by David Dronen for continued non-compliance with various village ordinances, including but not limited to obtaining a raze order. Attorney de la Mora summarized the building and the history. He asked Mr. Dronen to be present so he could be heard. Many residents have asked about the building since the fire. Mr. Dronen has not even pulled a building permit. He appreciates the fact that he wants more time. He did not justify why he needed more time. Financial limitations and he has to do the work himself. Start an action in Municipal Court to pursue the violations. It will cost the Village money either way. Mr. Dronen stated that he would like more time to get a permit, and he will speed it up. He intends to sell it and not move back in. Would like until October 30th. He will get some help and he does know people that will help him. Moore/Lake motioned to have the property listed by the end of June and start cleaning up the property or Hector has authority to pursue action. Motion carried unanimously.
